- 4) Valves with virgin PTFE seats (TFM) are tested in accordance with API 607 which qualifies valves with filled PTFE components may be used in vital system manifold, as isolation valves and to provide closures for opening in the shell of the vessel in accordance with USCG 46 CFR 56.20-15.
